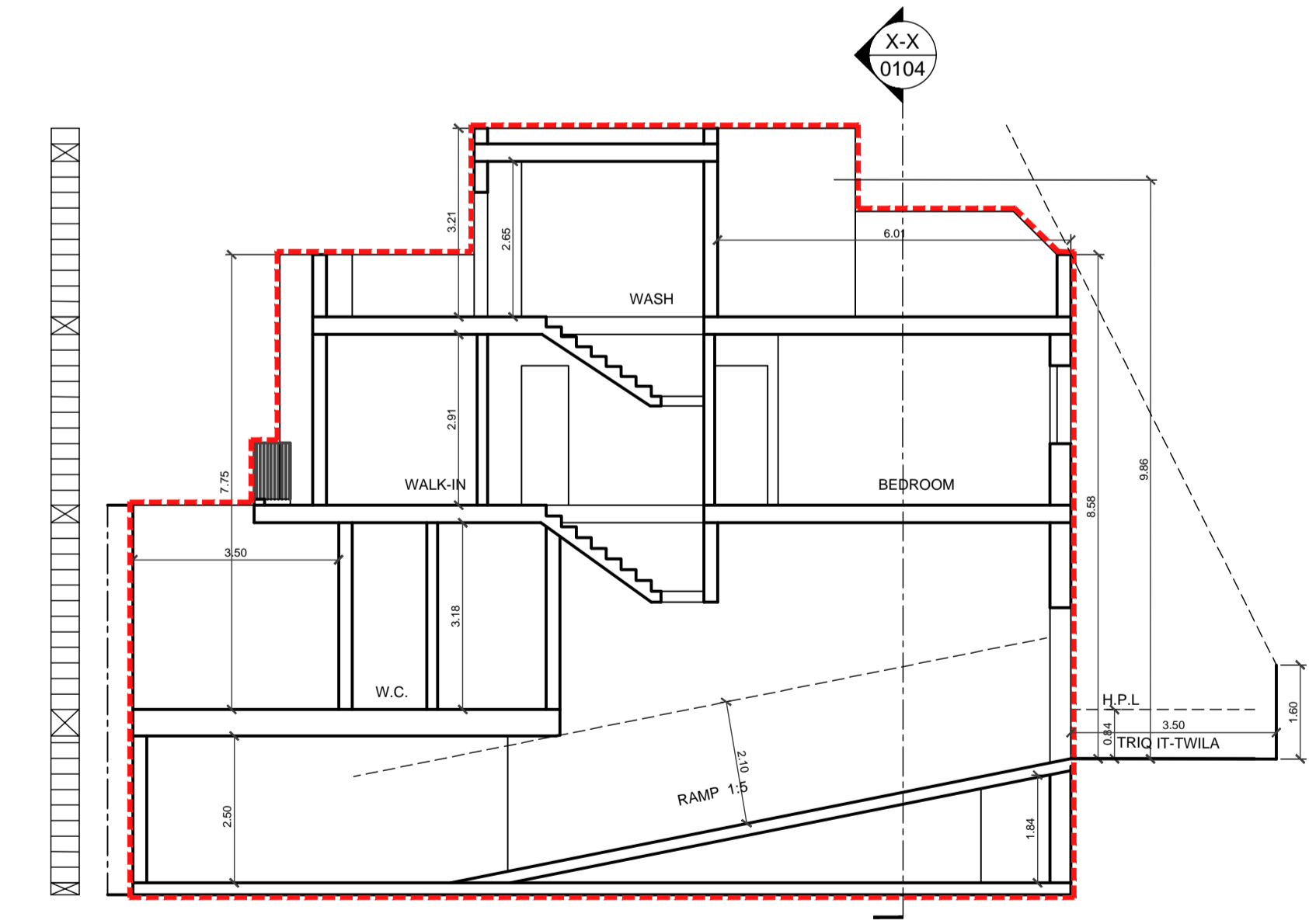




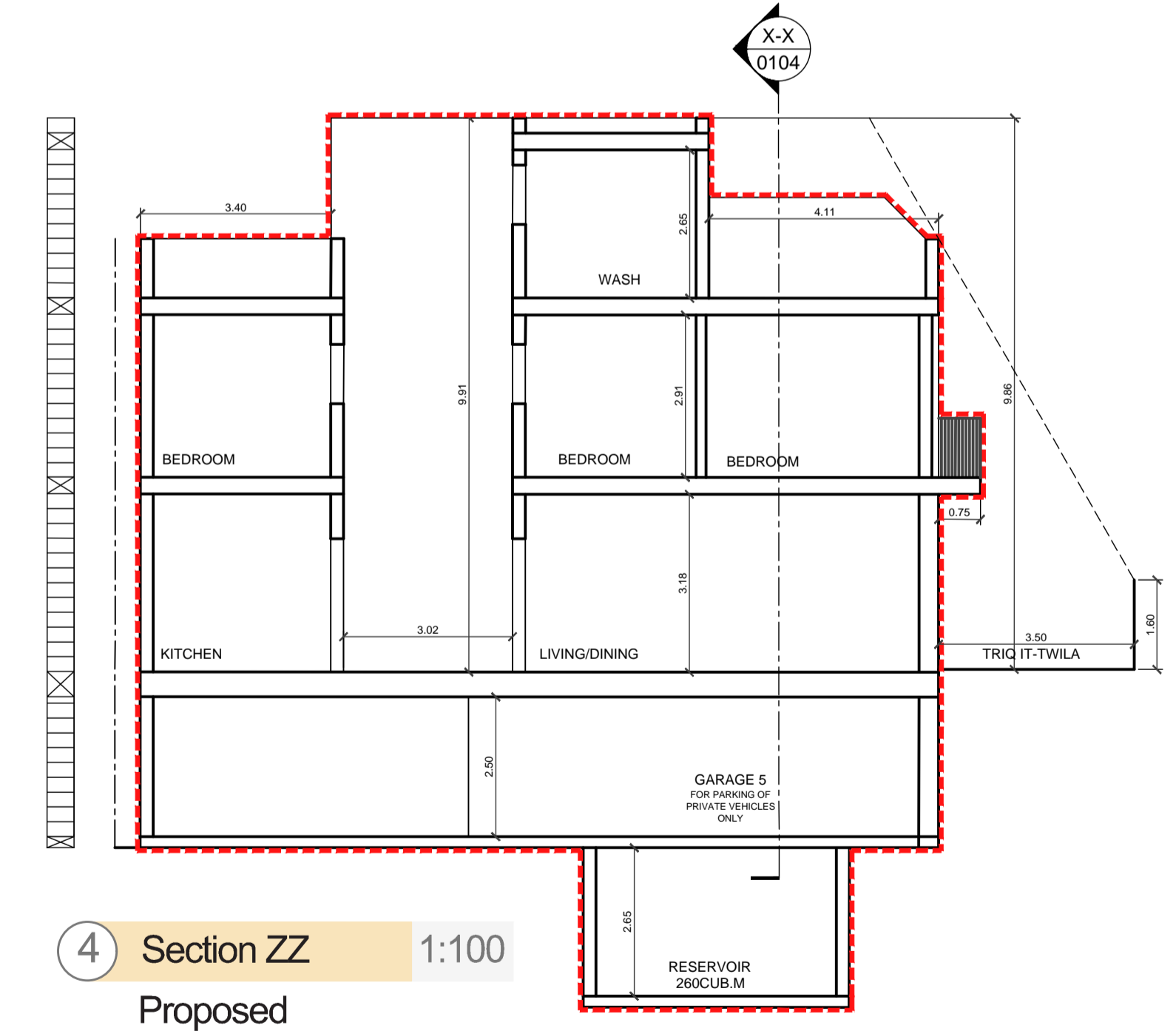
1 Roof Plan

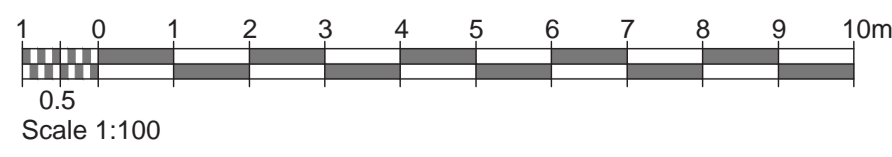
2 Section XX

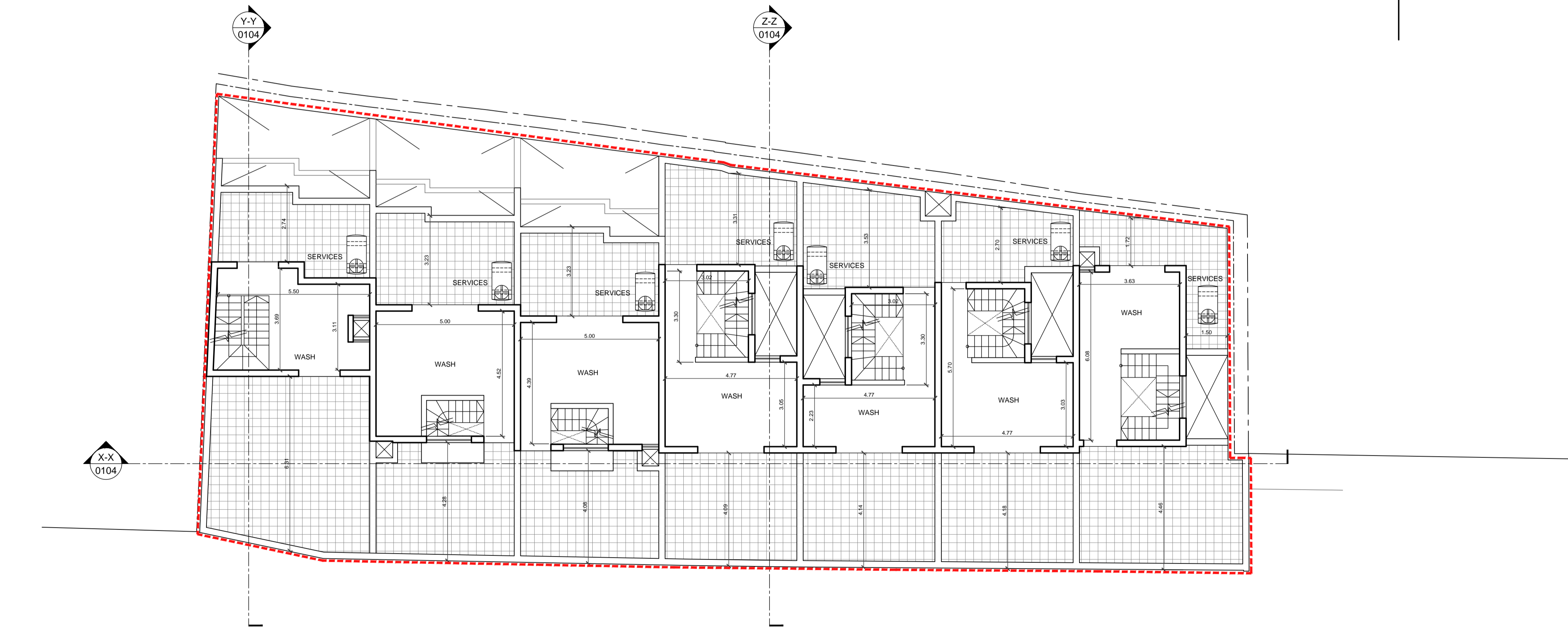
